#### Super Notes: Superintendent's Report By John Marshall

There are three topics that I want to talk with you about this issue.

The planned incorporation of all residents within the Pacific Coast Region and the Coast Division to automatic membership in both the region and division has hit a temporary snag. As a result, the anticipated expansion of the Coast Division has been delayed until such time as the National Headquarters gets their software modifications completed. It is still coming and we should not stop our efforts to make these NMRA members aware of our presence. We need to be proactive in welcoming them to the division and take every opportunity to extend a hand of welcome to them. In that spirit of comradeship I am requesting that the September Dispatcher be mailed to all. If you are receiving our publication for the first time, I urge you to read it thoroughly. Perhaps you didn't know that these ancillary organizations of the NMRA existed, or if you did, you chose not to join and participate in them. If you didn't know we were here to assist you and provide local fellowship in the hobby, shame on us. For that we are abjectly sorry. We want to be your local source for support in your model railroading activities, a resource for your problems, a sounding board for your concerns and provide you with an opportunity to learn more about what is going on in the hobby and advance your knowledge and skills. The second thing I would like to do is to congratulate Rod Smith on his selection as <u>Division Member of the Year</u> and also for receiving his Achievement Program Certificate. Both of these are major accomplishments. Rod has been a strong support for the Division and Region for many years. His recognition for that service is long over due. Rod also has every right to be proud of completing his AP certificate qualifications. I know that each and every one of you who know Rod have seen him quietly participating in division meets, on various boards and at regional, and when in the area, national conventions. Rod will celebrate his 50 years as an <u>NMRA member</u>, <u>Region member</u> and <u>Division member</u> in September 2006.

The third topic I want to discuss today is the Achievement Program. This program has not received the push in our division that I feel it deserves. A side discussion with Kermit Paul regarding the AP program at the last division meet got me thinking about what I could do to promote the AP program. It reminded me that as Clinic Chairman for the Division for the past 6 or 7 years, I have been remiss in not passing out the points earned by the members of this division for the clinics that they have provided at division, region and national level. With Rod's assistance, [there he is again] I have been able to compile a listing of those members, who, by their providing of clinics have earned points toward their AP certificate. The listing appears elsewhere in this issue. I have also asked the editor to include a copy of the applicable AP form for clinic presentations with this issue. I urge each one of you who has accumulated points to fill out a form and get it to me for signature as quickly as possible. I will sign them and deliver them to the AP chairman, Kermit Paul, as soon as I receive them. Bring them with you to the September meet and I will sign off on them there.

The next two years, you will hear a lot more from me regarding the AP program. I will be working toward my certification and I sincerely hope all of you will as well.

#### **Division Model Contest**

The results of the Model Contest in June were:

1st place Structures went to Andrew Merriam of SLO-Daylight Division (Andrew was also judged to meet his AP requirements with this model.)

1st place Display went to Mike Blumensaadt

1st place Self Propelled and Traction went to Alf Modine.

The categories for the September Meet are steam locomotives, diesel & other locomotives, and passenger cars.

Future Categories are:

December 2005: "favorite model" (open category).

March 2006: freight car, caboose, and maintenance of way.

June 2006: structure, display, and self propelled cars & traction.

September 2006: steam locomotives, diesel & other locomotives, and passenger car.

The list above includes all nine recognized model contest categories. Note that "diesel and other locomotives" includes heavy electric and all locomotives other than steam. Self-propelled and traction cars are a separate category. Displays are all dioramas or groups of models with significant scenery. All model contests will be decided by popular vote. It is also possible to have models judged separately for AP rating at the modeler's request.

We are looking for someone to run the model contest. All you have to do is lay out the table, have ballots available, and give the results of the balloting at the end of the day. The Categories are fixed in their rotation throughout the year. If you are interested, contact John Marshal.

In the June photo contest on "Model Photographs", Mark Schutzer won First Place, Tom Crawford won Second Place, and Mark Schutzer won Third Place.

September's theme will be "Railfans I've known."

The Coast Division Photo Contest has started to grow again. Unfortunately we can still use more entrants. This is a popular vote contest, so don't worry about the photo being "Great Art", just try to stay with the subject heading for each meet. The subject for the June meet will be "Model Photographs".

That means any photos of model trains, in any scale (EXCEPT 1:1) are acceptable. I would really rather not have any computer created photos, they'll have their own chance in the future. To help plan for September and December, here are the subjects for these future meets. The September subject will be "Railfans I Have Known". So get those photos taken of your "friends" on rail photo outings -- just remember, they may have photos of you also. The December meet will again be "Trains In Action". This means action photos of trains and or railroad equipment. Photos of static equipment is NOT included in this subject (we had some issues at the last meet, which I hope will be avoided this time).

All photos should be matted (inexpensive, reusable mattes can be had at most art supply stores) and should be between 5X7 and 11X14 in size. Hope to see your work soon.

#### Auction Update by Bill Burket

#### THIS IS IMPORTANT FOR AUCTION PARTICIPANTS - PLEASE READ.

At the recent board of directors meeting a motion was placed on the floor and passed to have more auction cards printed for the regular auction. As with everything these days the price of printing has gone up and the cost to the division is 38 cents per card for printing. 10,000 cards have been ordered which gets us the best price. To offset the cost and still provide quality auctions to our members all starting bids both silent and regular auctions will start at \$1.00. Like a lot of you I remember when we had cards printed free through members and the minimum bid was 10 cents. Those days are gone and I don't think the minmun of \$1.00 for a starting bid is asking too much. I do realize that this will take some getting use to so if you forget and place "Open" on your starting bid the auctioneer will start at no less than \$1.00. This also applies to the silent auction. Your board is doing the best we can for you, the member. We also have committee head vacancies that have been empty for several months and meeting locations are harder to find due to higher rents for facilities.

With the new dues structure within the NMRA I hope this will bring more members and participation to the meets. An increase in clinics and auction items would be a boost for Coast Division. Don't forget that items 51 through 100 are reserved for your brass items and that we accept any item related to railroading from N Scale to prototype and everything in between. Please do your part for Coast Division. I remember when we had an annual picnic and an annual banquet! If enough of you would step forward to help I do believe that we could see these fun social events come back. We'll see you all at the next meet September 11th and bring a model railroad friend for a day of fun activities and friendship.

How do you get a 727 from Wichita, Kansas to Renton, Washington? By train, of course. There will be a how-to model in the July SCALE RAILS. (Editor's note: It was there.)


